

2017-2018 High Flyers Registration Form

Thank you for registering with Echelon Academy's High Flyers After School Program for the 2017-2018 school year. Below is all the information needed to register your child. Registration Steps:

1. Complete the online registration at www.echelonacademy.org/afterschool/afterschool.php
2. Pay the one time, non-refundable \$25 registration fee.
 - If paying by check or cash, you may mail registration fee to High Flyers, 900 Olney Sandy Spring Road, Sandy Spring, MD 20860.
 - Only one registration fee per family.
 - *Registration fee is waived for all returning families.*
3. You will receive a confirmation email after we have processed your online registration form.

Tuition Information:

- Days of attendance cannot be exchanged.
 - During registration, you reserve the days your child will be in attendance. This is necessary to plan staffing and activities. Families must remain with the days they have signed up for, unless a permanent change of days is requested.
- Call-ins the day of are allowed and charged at a \$50 flat rate. High Flyers must be notified by phone or email before noon that day.
 - Transportation is not guaranteed for a call-in
- Tuition is based on enrollment, not attendance.
- The Sibling discount is 10% off the total monthly tuition.
 - Each additional sibling is an additional 10% off per sibling of family's monthly total.
- Tuition is due on the 1st of every month.
- Tuition price includes transportation.
- The most common form of tuition payment (and the easiest way to avoid late fees) is through an automatic payment plan with a credit card on file. Payments are processed the 1st of every month.
- June 2018 will be charged 50% as a partial month.
- There is a \$50 fee for each returned check.

Other Information:

- Daily snack will be provided.
- High Flyers will meet on MCPS early release days, ending at 6:30.
- High Flyers does not meet on days that MCPS is closed.
- **Late fees** begin at 6:30 pm:
 - \$1/per minute until 6:45, then \$5/per minute starting at 6:45.
 - Rates are charged per child.
 - Failure to pay late fees or consistent problems with lateness will result in dismissal from High Flyers.
- High Flyers allows a one-time, 3-day grace period for unpaid monthly tuition. Any following late tuition payments will be subject to a \$10 fee per day that tuition is late.

Parental Consent

I have read all the terms above, and agree to all terms. I understand that there is a \$25 non-refundable registration fee, and that all tuition fees are based on enrollment, not attendance. I understand and agree to pay the late fees on this form if necessary. All fees will be refunded if child is placed on a waiting list and not accepted into the program. I understand that full or partial payments may be made at any time, but that I will be billed once per month for all unpaid tuition. I understand High Flyers is a subdivision of Echelon Academy. I authorize High Flyers to administer Benadryl in case of an emergency allergic reaction if I cannot be reached. I understand that High Flyers cannot administer prescription drugs to my child, even with written parental consent, unless the medication is sent in a properly labeled container provided by a pharmacy and accompanied by the specific written authorization form provided in the parent guide. In the event that I cannot be reached in an emergency, I hereby give permission to High Flyers to hospitalize, secure proper treatment for and to order medical care including, but not limited to injections, anesthesia or surgery for my child (as deemed necessary by licensed staff). I also understand that I am financially responsible for the medical care of my child. My child has permission, without restriction, to participate in all snacks, regular and special programming, unless I notify the camp otherwise during registration. I understand and realize that all physical activities include a certain risk and High Flyers assumes no liability for injury or damage arising from or as a result of participation. I affirm that camp crafts, indoor and outdoor games, nature trails, and other camp activities include certain risks and dangers. These risks include, but are not limited to, personal injury, death, and loss of or damage to personal property. On behalf of myself and any child, I hereby release and forever discharge High Flyers and employees from any and all claims and causes of action of any kind or nature, arising at any time, related in any way or arising out of or in connection with food provided, and participation in any activities arranged for or by High Flyers, including any claims and causes of action caused in whole or in part by the negligence or any conduct of High Flyers and any of their employees. I intend to provide a complete release of any and all liability for High Flyers for injury, death, or damages of any kind. I will hold High Flyers and employees, harmless from any liability that may arise out of or in connection with any food provided and participation in any activities arranged by High Flyers and employees. I affirm that I am the natural parent and/or legal guardian for any minor child and intend to be bound by this Release and Waiver of Liability and intend to bind my minor child to this Release and Waiver of Liability. I understand and agree to all of the contents of the Release and Waiver of Liability. I understand and agree to all the above financial, first aid, safety, and other policies.
